Felicia Jordan, Vice Chair, called the meeting to order at 7:15 p.m. and led the Pledge of Alliance. F. Jordan provided K. Lefebvre and C. Nardi with kind words of appreciation on behalf of the Board. I. Vogt led the Pledge of Alliance.

Superintendent Case stated that according to the Canton Board of Education bylaw #9120, The Officers of the Board shall be the Chair, Vice Chair and Secretary who shall be elected annually by the Board at its regular meeting in December. Due to the full membership not being present this evening, it is recommended that the Board of Education suspend Board of Education Bylaw #9120 through January 31, 2023. This would require a 2/3 vote by Board of Education members present. This would allow the election of the Board of Education officers to occur at a later date on January 10th.

PUBLIC FORUM – Casey Levine, 51 Bristol Drive, Canton (Via email)

My name is Casey Levine and I have been the treasurer of Friends of Canton Football for nearly 4 years. I joined the board when my son was in 8th grade and looking forward to playing high school football and being a Canton Warrior. I was there in April 2019, when FOCF was informed that Canton had found the co-op they had been seeking, just not how they had envisioned. FOCF knew that football numbers had been declining and to ensure a safe, fun and successful team, joining forces with another town would be required. Of course, the hope was that a town would be joining us on our field that Canton would be the host school. That wasn't in the cards, but we trusted that the administration had worked hard and joining with Granby on their turf was going to be the best solution. We put our full support behind that plan, though uncertain of what the future would hold. The 2019 Fall season was quite successful. Our varsity team made the playoffs and the JV team was undefeated. The players really bonded and that has only gotten stronger as the years go on. And every year we have had a season since then (2020 withstanding), we have continued to make the playoffs.

A lot has changed since FOCF formed and was successful in getting football back in Canton in 2006. We have less players, and therefore less parents to do all the work required to fund the program. Don't get me wrong – many of our current parents are just as passionate as our founders, there are just far less of them. When football came back to Canton, FOCF paid for everything - coaches, referees, equipment, busses to away games, and every little cost you could imagine (including, for a time, funding the newly added Girls Lacrosse team). The Canton Board of Ed was generous to fund the equivalent of one JV coach salary beginning about 5-6 years ago, but FOCF still pays the balance. Our costs have changed with the co-op. Now instead of explicitly paying for coaches and refs and equipment, we pay a "per player" fee to Granby to cover all those costs. In addition, because our players travel to Granby 6 days a week during the season, we also fully fund the bus that takes them to / from. This additional cost is incurred solely because we are not the host school and therefore has nothing to do with the actual cost to run a football program. Our FOCF executive board met with Mr. DiPippo and Mrs. Hirth to request funding of the bus to/from Granby for the season be added to their athletic budget. We understand this is a tall ask. We also know that not having football as a Fall sport option would be detrimental to so many

of our young men. The skills they learn on and off the field and the sheer amount of time and effort they put into this sport year-round is a real foundation for their future.

Mike Forte, Canton/Granby Bears Football

Football in Canton has never been better, the programs are growing and thriving and the future of football looks promising. There is a total of 52 players with 8 great coaches, but coops and football programs are not easy and the football team has large costs, of which \$15,000 is spent on transportation with a total cost of \$34,000 to fund the program. The Athletic department provides \$4,000 to football. The reality for the future is co-ops. All three communities make for a very good team – fundraising has been an issue, concession stand is great but the funds go to the Canton High School booster club and the one large fundraiser that is typically had was rained out, so much money was lost. He is here tonight to request that Transportation be paid for through the budget process as it is for other sports such as soccer.

Svetlana Sandal, Elizabeth Road – Shared a Winter festival reminder and also stated that Senora Traub and some of her students went to Simsbury last week to work on a community project, Healing Meals, but unfortunately there wasn't many students who volunteered from Canton and she was wondering how more students/adults could get involved in such a great project.

SUPERINTENDENT'S REPORT, Kevin Case

Superintendent Case provided an update on a recommended program that he would like to bring to the School District. It's Mental Health Support for Canton Middle and High School Students. This support will be paid for by ARPA funds that have been put aside for students to help support social and emotional health. He shared a summary of the Student Assistance program and a representative from the company was present at the meeting to provide additional insight regarding the program. Focus of the program is to provide confidential, free support for student including unlimited coaching sessions via zoom and 24/7 crisis support access to clinicians. The program is completely voluntary and is designed to help students with personal, family or school related concerns. The company is called Health Management Systems of America and if approved, the effective date of the program for middle/high school students will be January 1, 2023. Superintendent Case also spoke about the NEASC visit that was held in early December stating how impressed the committees were with the High School and he thanked all involved to make the visit a great experience for the district. Was very impressed by the quality of work the students were doing and the quality of teaching that was observed as well as the CAMP projects that they reviewed. The committee will write up the report that will be shared with the Board at a later date. Lastly, he shared that the next Community Conversation on Diversity, Equity and Inclusion will take place on January 18, 2023 from 7-8:30 p.m. This will be the first, in a series of focus groups.

PRESENTATIONS

Superintendent Case provided an overview on the latest State of Connecticut Department of Education Accountability Index Report, focusing on the twelve indicators which make up the report.

Assistant Superintendent of Schools, *Jon Bishop*

J. Bishop provided an overview on the website update and provided special thanks to his assistant Lynn Young, Claudia Nardi, Kyra Lefebvre, Robin Nardini and all the support staff at the schools for their help to get this accomplished. He stated that there is a new button on the website that provides the opportunity for the public to provide website feedback. He shared that the Security RFP has gone out and that process is underway with a selection done prior to the end of the month to be able to support the safety of our schools. Also shared that there will be second community workshop hosted by Justine Ginsburg entitled "Social Media and the Minds of our Children" is scheduled for February 1st. March 8th will be the second workshop of the series and will focus on the "Anxious Child". Lastly, Mr. Bishop shared an overview of the 2023-2024 Program of Studies as a first reading.

Discussion: R. O' Donnell had a concern about the clinician's certifications and feels that as Board members, they have a responsibility to be able to answer questions about the program offering. He would love if there were something else that we can offer students such as meditation, yoga rather than students just pushing a button. K. Sullivan shared she has the same concerns as R. O'Donnell, but voted yes because the student reps advocated for the program. R. Bush stated he is all for it, but it seems to be brought to the board rather quickly with no real chance to review. J. Scheideler shared that he has some concerns, but trusts Superintendent Case has reviewed the proposed program and shared that he concurs with Ryan as he asked great questions.

Superintendent Case stated that he hasn't found any other program that would benefit our students. He will measure the utilization of services and if students aren't taking advantage of the program, the contract will be ended. He stated that utilization records will be reviewed monthly. R. O'Donnell asked that the contract be amended to state that specific language. Superintendent Case stated that he will work on that piece.

7.3. Signage

7.3.A. PURPOSE

It is the purpose and intent of this section to:

- 1. Accommodate the establishment of signs necessary for identification, direction and reasonable commercial promotion while providing minimum standards to preserve the character of Canton by regulating the size, height, location and lighting of signs;
- 2. Provide a reasonable and comprehensive system of sign controls to provide for fair and equal treatment of all sign users;
- 3. Protect the Town's character by avoiding clutter, while recognizing the need for signs as a major form of communication;
- 4. Encourage signs that are well designed and pleasing in appearance with good design relationship and materials location;
- 5. Encourage signs that are well designed with safe and appropriate spacing and location;
- 6. Promote public safety by providing that official traffic regulating devises be easily visible and free from nearby visual obstructions; and
- 7. Protect the residential, commercial, industrial, and recreational character of each district.

7.3.B. APPLICABILITY

- 1. No sign shall be established, constructed, reconstructed enlarged, extended, moved or structurally altered except in conformity with these regulations and until a sign permit, if required by this section, has been issued.
- 2. For any sign serving a use that was subject to a special permit, a modification of the special permit shall be required if the Zoning Enforcement Officer determines that a proposed change in size, shape, color, material, lighting or location significantly alters the character of the sign.
- 3. The following signs are expressly prohibited:
 - a. Any sign not expressly permitted;
 - b. Flashing signs, rotating and animated signs;
 - c. Moving signs;
 - d. Any motion-producing (dynamic) elements or features of any sign, except for wind induced flutter of awnings;
 - e. Signs capable of changing image using electronic control;
 - f. Signs with display screens using LED, LCD, plasma, or functionally equivalent technology;
 - g. Signs capable of slide show or series of stills, or full motion or a combination thereof;

7.3.C Standards - Signs in Residence Districts

- h. Sky signs;
- i. Any sign with an exposed source of illumination;
- j. Any wall mounted sign lacking fabricated individual letters; unless the sign is an approved promotional wall sign;
- k. Any sign with translucent cabinet faces enclosing any "light cabinet" (excepting individual letters);
- I. Signs with painted-on letters or sheet or film applied letters, except for temporary signs, open and closed signs, awning signs, and menu board signs;
- m. Off-premises signs (Billboards);
- n. Streamers, and banners.
- 4. There shall be no temporary signs (including a-frame, h-frame, and signs of similar construction) other than as provided in Section 7.3.C and Section 7.3.D of these Regulations.
- 5. Signs referenced in this section are illustrated in Section 4 of the Appendix.

Hi Lou,

My takeaway from the discussion was that the Commission was not willing to take the initiative to draft and submit a regulation change necessary to accomplish what you propose themselves. However, I believe they made it clear that an application from the BOE would be the more appropriate route.

An application would need to be prepared proposing a regulation amendment allowing 'digital signage' in the zones in which the public schools are located (Municipal Community Public Facilities District (MCPF)). Given the concerns raised regarding neighbors, I would recommend this be proposed by Special Permit, which means a public hearing would be scheduled (requiring public notices) prior to the allowance and siting of any one particular sign.

A similar mechanism was built into the Zoning Regulations for the lighting for athletic fields under Section 7.4 Lighting. See Section 7.4.D.4 and 7.4.D.4.f of the following:

Proposed Text

Similar language may need to be added to Section 7.3 Signage.

Possibly adding to Section 7.3.B.3 (prohibited signs) language such as, "Expect as may be permitted under Section 6.4.D" (Special Permit Uses in the MCPF). Then in 6.4.D add something such as, "6.4.D.5.f. Signage beyond the limitations of Section 7.3,B,3"?

These are just for suggestion and there may be a better or more practical proposal.

On behalf of the Board of Education, I would like to respectfully request that the Town of Canton's Zoning Regulations be modified. Specifically, Section 7.3B as it relates to Signage. We understand that the purpose and intent to such regulations is to provide a reasonable and comprehensive system of sign controls that provide for fair and equal treatment of all sign users while protecting the Town's character. However, it is important to recognize the need for signs as a major form of communication between the community and its citizens. We are writing to respectfully request a revision to Section 7.3B which states that Electronic Signage is expressly prohibited in the Town of Canton.

Electronic signage for purposes of communication within the Town of Canton and Canton Public Schools is critical. Signage will be beneficial for the Canton Community as it provides a visual reminder of all events and acts as another communication tool with the town. The collaboration with the Town and Canton Public Schools is an important one and electric signage will allow the community the transparency of open communication while providing community engagement as we strive for a continued safe community. It acts as an effective digital tool for updates on both town and school initiatives from school activity cancellations to meeting reminders to weather updates and even as a support system for local businesses and organizations. Presently many other towns in the Farmington Valley have electronic signage and Canton should follow suit as it provides another avenue for instant and visual communication within the community.

The Canton Board of Education is happy and willing to work with the Town of Canton's Zoning Enforcement Officer on the specifics of the signage to find a display that would look appealing to the Canton community as whole.
